Langlade County Snowmobile Council- Established 2015

Objectives of the Organization

1. To act as a liaison between member clubs and all bodies of local, county, state and federal government in matters affecting the sport of snowmobiling
2. To encourage cooperation between the various clubs represented in all activities that will promote the activity of snowmobiling.
3. 3. To develop understanding of the issues affecting the recreation of snowmobiling and communicate information so the image of snowmobiling will be enhanced. This effort should include, but not be limited to, educational programs, landowner relations, legislative review, trail development and safety.

Langlade County All-Terrain Vehicle Council- Established 2022

Objectives and Powers

Section 1. The objectives of the Langlade County All-Terrain Vehicle Council are to:

1. Encourage cooperation between various Clubs represented in all activities that promote the activity of ATVing/UTVing within Langlade County or connectivity of Langlade County to Statewide trail systems.
2. Develop understanding of the issues affecting the recreation of ATVing/UTVing and promote and improve the image of the activity of ATVing/UTVing.
3. Efforts shall include, but not be limited to educational programs, landowner relations, governmental relations, legislative review and comment, trail development, safety and law enforcement.

Section 2. Except as otherwise limited by law and by the provisions of these bylaws, the organization shall have, exercise and enjoy, in furtherance only for the purposes herein set forth, the following rights, privileges and powers:

1. To act as a liaison between member Clubs and all bodies of local, county, state and federal government in matters affecting the sport of ATVing/UTVing within Langlade County.

Langlade County Wildlife and Fisheries Council- Established 2025

Objectives and Powers

Section 1. The objectives of the Langlade County Wildlife & Fisheries Council are to:

1. Promote and support wildlife and fisheries habitat retention, management, and improvement on the Langlade County Forest.
2. Promote the education and support of healthy habitat and ecosystems for Wildlife and Fisheries to develop an understanding of issues that negatively affect these habitats
3. Encourage cooperation and partnerships between interest groups and Langlade County Government to promote and support Wildlife and Fisheries habitat on the Langlade County Forest.
4. Identify and assist with completion of wildlife and fisheries projects in Langlade County
5. Recognize and support tourism industry related to wildlife and fisheries including but not limited to hunting, fishing and wildlife viewing within Langlade County

Langlade County Silent Sports Council- To be Determined

Objectives and Powers (Draft TBD)

Section 1. The objectives of the Langlade County Silent Sports Council are to:

1. Promote and support silent sports trails, facilities, retention, management, and improvements on the Langlade County Forest.
2. Promote the silent sports activities, programs and development across Langlade County. education and support of healthy habitat and ecosystems for Wildlife and Fisheries to develop an understanding of issues that negatively affect these habitats
3. Encourage cooperation and partnerships between interest groups and Langlade County Government to promote and support silent sports within the Langlade County.
4. Identify and assist with completion of trail projects, route connections, activities and promotions in Langlade County
5. Recognize and support tourism industry related to silent sports including but not limited to hiking, biking, cross-country skiing, downhill skiing, sledding, paddling, horseback riding, bird watching and wildlife viewing within Langlade County

Section 2. Except as otherwise limited by law and by the provisions of these bylaws, the organization shall have, exercise, and enjoy in furtherance only for the purposes herein set forth, the following rights, privileges and powers:

1. To act as a liaison between members of local communities and the Langlade County government in matters affecting silent sports activities on the Langlade County Forest.
