Under this permit issued by the LANGLADE County Forestry, Recreation and Land Department, Permission is granted to Permittee to harvest one Christmas tree upon the LANGLADE County Forest for the **between November 15th and December 25th of the 2024 season**

Christmas tree means the gathering/cutting of trees for personal use in home decoration under the following conditions.

1. Christmas tree cutting is only authorized in in the Towns of Parrish, Elcho, Ainsworth, Summit, Upham, Langlade, Price and Evergreen. No Christmas tree cutting is allowed in the Gartzke Flowage Recreation Area, the Jack Lake Park area or at any designated park or on any designated ski trail.
2. A permit must be in immediate possession of the permittee when in the process of cutting, taking, and/or transporting firewood from the forest.
3. Permit is for cutting Christmas trees for the personal use of the permittee or his/her immediate household, or his/her immediate family. Cutting of Christmas trees for commercial sale is not allowed under this permit.
4. Tops or branches **shall not** be left on roads, ditches, trails or within lakes or streams.
5. Permittee retains all responsibility for knowing the property ownership prior to cutting of trees under this permit.
6. Failure to comply with conditions of this permit may result in permit revocation and/or prosecution of the Permittee for Forest Products Theft.
7. Permittee agrees that LANGLADE County or any County Contractor, including logging contractors, cannot be held liable for injuries or accidents resulting from any permittee actions or omissions under this permit. Permittee assumes and agrees to protection, indemnify, and save harmless the Owner (Langlade County), its representatives, agents, officers, and employees from and against any and all claims, demands, suits, causes of action, liability, costs, or expense by reason of loss or damage to any property or bodily injury to any person, including death, as the direct or indirect result of operations under this permit or in connection with any action or omission of the Permittee, who shall defend the Owner, its representatives, agents, officers and employees in any such cause of action, claim or suit.
8. The LANGLADE County Forestry, Parks and Recreation Department reserves the right to cancel this permit at any time.
9. Failure to comply with conditions of this permit may result in permit revocation and/or prosecution of the Permittee with penalties as outlined in Federal and State Regulations and County Ordinance.
